You can swap your council or housing association home with another tenant if you follow certain rules and get permission from your landlord. This is often called 'mutual exchange'.

You should contact your landlord if you're a housing association tenant and want to swap homes.

Tenants **MUST** be aware that they risk losing the security of their current tenancy if they swap, as they will exchange the tenancy as well as the property
